2022 REVIEW



2022 was an amazing, fastpaced year! With the help of dedicated staff and volunteers Brunswick has made it into media platforms county and state wide. This year Brunswick Main Street partnered with Frederick County Office of **Economic Development and** Frederick County Tourism to produce a fantastic video that shared our town's rich music history and BMS was awarded another TRIPP grant to produce a "Stay in Brunswick....where adventure awaits" commercial!

- Awarded \$325,000 in ARPA funds for Building Blocks Program
- Awarded \$105,000 in grants from the State of MD for Facade & Interior Improvement Program & Community Safety - Martin's Creek Parking lot
- Awarded \$24,000 from Frederick County for the TRIPP grant to produce commercial & C.A.N. grant which funded musicians
- Welcomed 5 new businesses downtown
- Hosted Marketing Strategy workshop & gave mini grants to attending businesses

Brunswick Main Street remains committed to supporting our downtown. In 2023 we will focus on partnering with the City to continue the work of finding connectivity options to the Towpath, Canal and Potomac River. Also at the top of the list will be to support the businesses downtown (especially on the first block of West Potomac and Maple Avenue) when the construction begins for the new development. Grants will continue to be a priority as well as being involved with the future of the historic Kaplon Building. Developing Brunswick as an outdoor recreation destination and supporting the growth in Brunswick's art culture will remain the strategic goals.






